

## Offbeat Party Rental Agreement

**In consideration of renting equipment from Offbeat Party Rental, the Client agrees to the following terms and conditions:**

**1. Rental Period:**

- The Rental Period begins at the time of delivery/pick-up and ends at the agreed-upon time of return.

**2. Payment Terms:**

- A 25% non-refundable deposit is required to secure the booking. The remaining balance is due the Monday before the event or 1 week prior to the event. Payment can be made via credit/debit cards, Zelle, Venmo, Apple Pay, cash, or check.

**3. Delivery and Setup:**

- Offbeat Party Rental will deliver, set up, and pick up all rental items for additional cost (based on location). The Client agrees to provide access to the event location (e.g., parking, entrance fees) and necessary utilities (e.g., electricity) for setup and operation.
- Late arrivals/no-shows: The Client must be present at the agreed-upon delivery time. If the Client is more than 30 minutes late or fails to show up, a late fee of \$30 will be charged. If Offbeat Party Rental is unable to complete the delivery due to the Client's no show, the Client will forfeit the services and no refund will be given.

**4. Damage and Loss:**

- The Client is financially responsible for any damage or loss of rental items beyond normal wear and tear. This includes, but is not limited to, holes in linens, broken chair legs, paint on inflatables, and any other physical damage.
- The Client agrees to return all rented items in the same condition as received, except for normal wear and tear.
- Our Items are not weatherproof, so please be sure to protect the rental items.
- **Damage Fees:** All items will be assessed for damages and the fees vary depending on the items/equipment. A refundable damage deposit (price based on rental) is required at the time of booking. The deposit will be refunded in full immediately, providing all rental items are returned in good condition/damage free. A minimum damage fee of \$25 will be charged if rental items are returned with damage or require extra cleaning.

**5. Inspection and Notification:**

- The Client or an authorized representative must inspect the rental items upon pick-up or delivery and notify Offbeat Party Rental of any issues or damages immediately. Failure to do so will result in the Client being held responsible for any subsequent damage discovered. Please take photos.

**6. Use of Equipment:**

- The Client agrees to use the rental items only for their intended purposes and to follow all safety instructions provided by Offbeat Party Rental. Proper supervision of children/minors must be provided at all times during the use of the equipment.

**7. Indemnification:**

- The Client agrees to indemnify and hold harmless Offbeat Party Rental, its owners, employees, and agents from any and all claims, damages, losses, and expenses arising out of the use of the rental items. Please see the Liability Wavier and Release Form for more information.

**8. Cancellation Policy:**

- Please cancel at least 1 week in advance to avoid being charged the full rental amount.

**9. Force Majeure:**

- Offbeat Party Rental shall not be liable for any failure or delay in performing its obligations under this agreement due to circumstances beyond its reasonable control, including but not limited to acts of God, natural disasters, or government restrictions.

**10. Governing Law:**

- This agreement shall be governed by and construed in accordance with the laws of Georgia, United States.
